## IMPORTANT: READ BEFORE REMOVING FIXTURE FROM CARTON, RETAIN FOR FUTURE REFERENCE


**SAFETY:** This fixture must be wired in accordance with the NATIONAL ELECTRICAL CODE and applicable local codes and ordinances. A person familiar with the construction and operation of the product and the hazards involved must install this product. A qualified licensed electrician should complete all work. Proper grounding is required for safety.

**WARNING**: Make certain power is OFF before installing or maintaining fixture.

**RISK OF INJURY:** Fixture may become damaged and/or unstable if not installed properly.

#### MOUNTING

- 1. The fixture has been provided with a trunion bracket for mounting on flat surfaces.
- 2. Secure fixture with 3/4 inch SAE2 grade bolt (tighten to 125 pounds).
  - Note: Clearance hole for 3/4 inch bolt needs to be a minimum of 1.125 inches from edge of flat mounting surface.
- 3. Follow aiming instructions.



#### WIRING

NOTE: Use Supply wire (6' hard service cord supplied) rated for 90°C

- 1. Turn off electrical supply at the breaker.
- 2. Follow all electrical codes for wiring and grounding requirements.
- 3. Check to make sure the supply voltage to the fixture is compatible with the fixture ballast.
- 4. Connect the white fixture wire with white service wire.
- 5. Connect the black fixture wire with black service wire.
- 6. Connect the green fixture wire to the ground wire.
- 7. Make sure all connections are secure using approved connecting devices.

### **AIMING**

#### Aim The Luminaires

Aiming the luminaires is a critical part of the LED lighting solution to ensure that light is evenly distributed on the playing surface. There are two basic methods to properly aim a sports venue – Precision Laser Aiming by Coordinates, and Orient-Tilt.

The date of the postmark of the mailing to Atlas shall constitute the date of notification under this warranty. If the information is e-mailed, the date that the e-mail is sent to Atlas shall constitute the date of notification under this warranty. Upon receiving a timely notification, Atlas will, if the notification reflects a failure of materials or workmanship, provide a Return Goods Authorization number and full instructions for returning failed merchandise. All returned goods must be accompanied by a Return Goods Authorization number issued by Atlas.

SOLE REMEDY: REPAIR OR REPLACEMENT: If, upon receiving a timely notification with the information stated above and receiving merchandise that appears to Atlas to have a failure in materials or workmanship, Atlas will — at Atlas's sole option — either repair the failed part(s) or provide a replacement part or parts. This remedy constitutes the sole remedy under this warranty and Atlas's sole liability in connection with any failed part(s). 
# AIMING (CONTINUED)

## **Precision Laser Aiming by Coordinates**

Laser aiming is the most effective and preferred technique for aiming LED sports lighting. This method uses a laser mounted to the luminaire to point the fixture at a predetermined point on the playing surface using (X,Y) coordinates. Unless otherwise noted, aiming coordinates on photometrics or project Installation drawings are based on the origin (0,0,0) placed at center field, court, or ice. All dimensions from that point are in feet along the playing surface unless otherwise noted.



With the Orient-Tilt method, the installer turns the luminaire according to predetermined angles. This technique is extremely helpful for pre-aiming fixtures mounted on a cross arm on the ground before the lighting pole is lifted up and set in place. However, this method is less accurate due to the variances in actual final pole and luminaire locations and



orientations compared to the approximated parameters used in the photometric design. The Orient angle refers to the direction the luminaire faces in the Z-plane. In other words, mount the luminaire to the structure but leave the mounting nut slightly loosened to allow the entire fixture to spin about the mounting bolt. Set the luminaire Orient by rotating the luminaire mounting bracket relative to the mounting structure. Unless otherwise noted, Orient values shown in photometrics or project Installation Drawings are based on 0° being Plan East. Plan East means 0° is heading to the right side of the sheet as you hold it in front of you, which is not necessarily geodetic or True East.

The Tilt angle refers to the direction the luminaire faces in the Y-plane. When the luminaire is securely mounted to the structure so that the mounting bracket does not move but the side Hex and Set screws are loosened, the fixture may rotate up inside the mounting bracket. Set the luminaire Tilt angle by rotating the fixture housing relative to the luminaire mounting bracket.

- 1. Insert the laser or tube into the aiming mount and lighten the holding screw.
- Insert the aiming mount onto the fixture aiming pin until it is fully seated. Aiming mount must be tight against the fixture because any movement or wiggle in the mount will cause aiming to be inaccurate.
- 3. Slightly loosen the fixture aiming screws just enough to allow the fixture to rotate and tilt.
- 4. Turn on the laser and aim the fixture by targeting the red laser dot at the aiming point. If aiming tube is used, look through tube and adjust fixture until aiming point is centered in view through tube. Refer to photometrics or project installation drawings for aiming point coordinates.
- 5. After aiming is complete, tighten all bolts and screws including hex and set screws on side of fixture and mounting hardware.
- 6. Briefly turn the laser back on or re-check view through tube to verify that the luminaire aim did not shift during tightening.
- 7. Remove the aiming mount from the fixture and proceed to the next luminaire.
